We don't have a drug court program in our juvenile court system and don't have any specific data on recidivism rates.
Additional information About Substance Abuse *

We have not had a significant number of substance abuse charges in juvenile court in the last couple of years, but after several meetings with schools and community members, it has become evident that the newest trend that is rapidly growing in our area with both adults and youth is THC vape pens, otherwise known as "dab pens." Due to current legislation about the % of THC that is "legal" in AL, our DA's office has determined that these
"dab pens" are not able to be used to charge someone with possession of marijuana, despite them testing positive for THC in LEO field tests. These devices are becoming almost as common as regular vape pens amongst juveniles, and we are finding them with kids at younger and younger ages every year. The legislators need to look into what it would take to pass a law that would allow these juveniles to be charged with something so that we can help the school systems combat this problem.

There are several factors that potentially contribute to incidents of domestic violence and child abuse such as a lack of access to mental health services, the socioeconomic status of many Jackson County residents, limited resources for anger management and family counseling, the rising issues of substance abuse, and the rural landscape of the county.

Describe how the unmet needs are currently addressed.

For juveniles, we have a Juvenile Court Liaison through Mountain Lakes Behavioral Healthcare that can assist with filing with the juvenile court if a child is in need of residential care. She is also able to help the parents and guardians get the child to a hospital that can help with assessing an acute issue. We also have the county Multi-Needs Team that meets monthly to discuss children in the county that may require residential care for mental illness related issues. That MNT can request funding from the state MNT to cover the cost of that residential care. There are no residential placements for juveniles in our county, and there are very limited beds in the state, so many times children are held for a short period and released back into their parents or guardians care and referred to a local counselor for follow up care.

For adults in the area, many are referred to Mtn Lakes Behavioral Healthcare for counseling and referrals for inpatient and medication services. We also have Highlands Medical, our local hospital, that can see all patients for acute assessments. Our probate judge also has the power to intervene in adult commitments, although beds and resources across the state are still extremely limited.

Describe the greatest mental health needs in your county.*

We need services for juveniles that are experiencing acute or long-term mental health crises such as suicidal and homicidal ideations, and severe behavioral issues. We are seeing more and more reports of severe behavioral issues at young ages, especially from the schools, and at this time, our main resource to provide them services is our county MNT. Our county mental health department, Mountain Lakes Behavioral Healthcare, is understaffed compared to the need, and they have a history of high staff turnover which makes it difficult to provide consistent care to patients that need it. Many people are only seen once every 4-6 weeks, which is often not enough. We need more staff to be able to provide mental health services and potential residential or intensive programs.

Accomplishments

Accomplishment 1*

Describe this accomplishment.

Our Youth Advocacy Program (YAP) is our most helpful tool and resource, especially when it comes to our juvenile justice kids and those families with DHR involvement. They provide one on one mentoring services at least 10 hours a week and work in the homes, directly with the families. This program has been such a tremendous asset in the past couple of years, that we coordinated with them to apply to expand and fund the program to be able to service 10 juveniles per year, in contrast to the 6 per year that they have been able to serve.

They are also in the process of opening a YAP house that will serve as a location for family visitations, parenting and skills development, cooking classes for parents, homework stations to assist families and children with reading and homework, a safe place for our youth to do homework at and hang out at after school and during the summer. This house is currently going through the preparation stage and hopefully should be open for the public within 4-5 weeks.

Who benefitted from Accomplishment 1?*

Our juvenile justice children and children that have cases with our Department of Human Resources. We have had 4 juveniles complete the program during this evaluation period and none of them have had any new criminal charges since their successful completion.

Accomplishment 2*

Describe this accomplishment.

Strengthening Families parenting classes are held once a week for 14 weeks. Trained facilitators lead the classes, which consist of separate child and parent classes, as well as an instructional period each week that includes the entire family. Parenting strategies and skills are taught in the adult classes while the children's classes are taught a lesson tailored to them about the same topic the parents are learning that week. In the last hour, the parents and children come together to work on putting the newly learned skills to real use. A family meal is also provided at the beginning of each session.

Who benefitted from Accomplishment 2?*

SF served 27 parents and 41 children during the reporting period. Anyone living in the home where the children are living or where they were removed from are required to participate in SF as part of their voluntary commitment to Jackson County's Family Wellness Court.

Accomplishment 3 *

Describe this accomplishment.

Our Jackson County Juvenile Probation Office provides an Early Warning Truancy Prevention Program to help our local school systems combat the truancy issues from Kindergarten through 12th grade. This program helps to educate and hold the parents and children accountable for their absences and responsibilities when it comes to following both the school's rules and the Alabama laws about attendance in public schools. This allows the families to meet with court personnel, the Juvenile Court Judge, a representative from the District Attorneys office, and the school representative that tracks attendance, and handle their case without having to come to court and face further court action.

Who benefitted from Accomplishment 3?*

We were able to serve 248 families this year and assist them in understanding the compulsory attendance laws, avoid court action, and many times get clarification from the school representatives.

Accomplishment 4

Describe this accomplishment.

Jackson County's Family Wellness Court implemented an OJJDP Prevention Services program titled Substance Abuse Education Series that also addressed mental health and self-care. This program was taught to Scottsboro High School students, who then went into the Scottsboro elementary schools to teach the elementary age kids the skills and information they had learned.

Who benefitted from Accomplishment 4?

In the reporting year, 126 high school students completed the SA Education Series, and many more elementary aged students also received the benefit of the program. As of the time of this report, two middle schools in the Jackson County School District have inquired about implementing the SA Education Series in their schools.

Describe this accomplishment.

Scottsboro City Schools began teaching the Parent Project this spring of 2023 and has since collaborated with Jackson County Schools to offer the program to a larger of parents starting in the fall of 2023. The parents that have participated in the program have been referred from juvenile court. This program is a 10-week program that teaches parenting techniques, life skills, and healthy family interactions.

Who benefitted from Accomplishment 5?

This program began in the spring of 2023 and the first class had 5 sets of parents complete the program. They are looking to serve many more families this fall when they collaborate with Jackson County Schools to offer multiple time slots for the classes.

Accomplishment 6

Describe this accomplishment.

Scottsboro City Schools hosted a family movie and resource night this spring of 2023. They provided a family friendly environment to entertain families, provide refreshments, and introduce families to multiple agencies and resources that provide services in our area. There were 13 community agencies that attended and set up informational booths that parents could obtain information from. The families were provided with punch cards that they could get stamped at each booth. They were able to turn in that punchcard once they had gotten every booth's stamp to be entered for a prize. This encouaraged the families to fully engage with each agency and find out about previously unknown resources.

Who benefitted from Accomplishment 6?

Approximately 350 families attended the program and visited the informational booths to learn about local resources.
