Clients are referred to the nearest hospital where they are assessed. If the person is classified as high-risk by the hospital staff, they they are referred to an in-patient clinics in a neighboring county. One problem is that many of our families do not have adequate transportation to transport their child to the hospital then to an in-patient facility out-of-county; therefore, students' needs are not met. Another problem is that if the in-patient facility in the neighboring county is full, the student is put on a waiting list for in-patient treatment facilities in the state. This is extremely difficult for families.

Describe the greatest mental health needs in your county.*

The greatest mental health need is more adequate mental health services with providers that can prescribe medication for students in need. The enrichment center caseloads are packed full, and they can only see students during school hours.
