The Talladega County Board of Education was awarded \$1.75 million from the Alabama Public School and College Authority last year for the mitigation of 30 acres of property previously housing the textile mill. TCBOE is partnering with members of the Talladega County CPC, business and industry, SAFE, K-12 education, and Central Alabama Community College to create the East Alabama Rural Innovation and Training Hub. A bid was approved last week and cleanup will be completed in 150 days.

CHILDERSBURG FIRE DEPARTMENT – SUMMER 160 FIRE COLLEGE

Program Overview 160 Hours Fire College curriculum – equivalent to a Fast Track program normally taking 2 years to complete. Upon graduation, the candidates are rated FF-1 and eligible for immediate hire. The Fast track program has caught the attention of Fire Depts across the nation , as departments are struggling to recruit fire fighters. As an additional bonus, the normal pass rate for students are normally 20-30%. Thus far , the pass rate on the students tests is 100%! The graduates returning to high school plan to enroll in the EMT curriculum and as a WFR complement to the Fire College certifications Time Period: M-F 8:00 – 5:00 June 2022 for 160 hours Participants Open to High School Juniors and Up 12 Participants – TCBOE students
