Macon County has developed and spearheaded with other community stakeholders, comprehensive literary strategies to ensure reading proficiency on grade level by fourth grade.

Accomplishment 4	The MCCPC has collaborated with the Macon County Board of Education, to convert 3 surplus school buses into repainted bookmobiles to travel throughout the county. These bookmobiles will give away books to families and encourage parents to read to babies beginning at birth and to encourage children of all ages to develop a love for reading. Hopefully, the bookmobile effort will change the culture that learning only occurs in school, but by empowering parents to believe that the child's reading proficiency can also be enhanced at home.

Accomplishment 5	MCCPC continues to collaborate with the Gift of Life Foundation, Inc with the implementation of the Foundation's state grant which began in 2019 to address the high infant mortality rate in several counties, including Macon County. In 2021, 7 Macon County women graduated from the program. Twenty- two (22) of the women served have given birth, with 0 low birth weights, 3 preterm births and 0 infant deaths. 86% of Macon County mothers have breastfed their babies at least once and 90% report practicing safe sleep. Over 200 referrals to services have been made and 100% of Macon County mothers report that their infants/toddlers have health insurance.

Accomplishment 7	MCCPC donated \$500.00 to the Macon County Board of Education, to support the feeding of needy families during the 2020 Christmas Holiday. MCCPC has supported this annual "Christmas in a Bag" program since 2016. Also, MCCPC participated on the task force that created information on all sources of media, including social media, public service announcements, and community outreach programs, for the 2020 Census enrollment. The overwhelming effort resulted in Macon County having the largest percentage increase in the 2020 Census and took first place in the State, resulting in a \$65,000 check being awarded to the Macon County Board of Education.

A Tuskegee Police Officer appeared in his top hat and bow tie enthralled everyone with his book machine, video clip, and sing-along-read-a-book rap. The officer has published storybooks for children which are individualized and personalized to convey that EVERYBODY Has A Story to Tell. Books for children were given away, and books were for sale and signed by the authors. The children also painted pictures and played games.
