For the year of 2022 we have a 20% recidivism rate. We deal with our juveniles with drug issues on an individual bases as opposed to grouping them in a drug court setting. Health Connect provides most of the drug counseling services for Franklin County. We do have an adult drug court. Any in-patient drug treatment has to be done by service providers outside of Franklin County. We are even using some in-patient facilities in Mississippi.

Due to the lack of in-patient beds in our county we have to use beds in other counties. The wait time for the bed space can be lengthy. Based on limited in-patient resources we are using more out-patient counseling services.

The greatest mental health issue at present is the significant increase in drug induced psychosis. We are seeing this more and more in young adults. They are often homeless and are being arrested for various criminal offenses. The Franklin County Jail has approximately 10% of the inmate population that need mental health service.

We have a Special Programing Achievement Network (SPAN) Program. This program provides educational and counseling services to at-risk youth. These students are educated outside of the normal classroom setting with more one on one educational instruction and daily access to counselors. These students work on two educational tracts. Tract one provides credit recovery with a focus of returning the student to the regular classroom on their appropriate grade level. Tract two prepares the students for their GED certificate. A total of 24 students successfully completed the program in 2022.
